**1. Professional activities at the date of your appointment to the FPL board and those of the preceding five years?**

“Journalist with Mediapart. Author of several books, including; ‘Eloge des mauvaises herbes’. ‘Ce que nous devons à la ZAD (Les Liens qui libèrent, 2018), ‘Je crise climatique’ (2014), ‘La France Invisible’ (2006), ‘Le B-A Ba du BHL’ (published in France in 2004 by éditions de la Découverte, also published by Verso in the United States and the UK in 2012).

I have also conducted several debates and held a number of conferences, for public institutions such as the French cultural centre in Athens in January 2020, the Pompidou Centre in 2017, the Lower Normandy region in 2015, the CAPC Bordeaux museum of contemporary art in 2015. Some of my appearances were remunerated, before the establishment of Mediapart’s code of ethics.

I was also invited in November 2019 by the New York University to take part in a symposium ‘Rewiring democracy between us and them’.

I took part in organising and animating, 2019/2020, a seminar at [Paris social sciences school] EHESS on ‘Eco-feminism in combat’.

I authored a text for the catalogue of the Mucem [Museum of European and Mediterranean Civilisations] for the exhibition ‘Vie d’ordures’ in 2017. I also led a day-long workshop for researchers called up for the exhibition in 2015.

I wrote the preface for the book ‘Chroniques altermondialistes de Starhawk’, published by Cambourakis in 2017.

I contributed to the catalogue of ‘Lieux infinis’, which accompanied the exhibition at the 2018 Venice biennial.

In 2017 I worked on a TV documentary project about the pollution at a petrochemical site at Lacq [in south-west France] for production company Point du Jour.
